What is PIBC? And why be a member?

Professional planners use their knowledge, experience, skills, and insights to help shape more liveable, sustainable environments and communities. The Planning Institute of BC (PIBC) is the professional association for planners in British Columbia and the Yukon. It is the westernmost affiliate of the Canadian Institute of Planners (CIP), which has advanced and promoted responsible community planning since 1919.

History

PIBC was incorporated in 1958 under the Society Act of BC with just eight founding members. Fifty plus years later, it has more than 1,500 members.

Leadership

PIBC is led by an elected council of 12 volunteer members who work with staff to develop and support the strategic plan, guide and oversee business activities, set and monitor policies and protocols, establish annual budgets, and advance and promote the planning profession and PIBC. The council is elected every two years. PIBC also organizes professional development events and upholds professional and ethical standards.

Structure

PIBC has its main office in Vancouver and nine chapters across BC. The chapters help members in different regions to meet, network, and organize *continues over...*

- Certification as an RPP (Registered Professional Planner) in BC and the Yukon

- Exposure and profile within the profession (e.g., online consultant and resume postings)
- Annual awards for planning excellence and individual achievement.

Membership Options

Members work in the public and private sectors, and in many planning fields—including landuse and development, municipal and regional planning, resource and environmental management, policy planning and law, heritage conservation, sustainability planning, transportation planning, economic development, urban design, and more.

PIBC offers a number of categories of corporate and non-corporate memberships.

CORPORATE MEMBER categories include Certified Member, Candidate Member, and Fellow (honourific designation for Certified Member).

Certified Members in good standing have the exclusive right to use the title 'Registered Professional Planner' and designation 'RPP' in BC and the Yukon. They may also use the designation 'MCIP' to indicate their professional status nationally with the Canadian Institute of Planners. PIBC's more than 1,200 corporate members have voting rights and enjoy equivalent joint membership with the Canadian Institute of Planners.

Chapters include South Coast, Fraser Valley, Central North, Okanagan Interior, Sunshine Coast, Vancouver Island North, Vancouver Island South, Kootenay-Rocky Mountain, and the Yukon. Members are encouraged to participate in chapter activities, many of which provide Continuous Professional Learning (CPL) units for participation.

Committees

PIBC has several committees that help administer and oversee its activities.

While the Executive Committee focuses on financial, legal and personnel matters, other committees direct membership, education, communications, and awards. The Professional Practice Review Committee administers the PIBC Code of Ethics and Professional Conduct and investigates complaints of alleged misconduct against members. PIBC also appoints or nominates
