#### **General Accountability**

Reporting to the Manager Long Range Planning and Sustainability, the Senior Planner - Housing and Community Development, is responsible for a diverse workload focusing on affordable housing, long range planning, and strategic corporate planning initiatives.

Responsibilities include coordinating the planning and development of affordable housing initiatives, leading the City's work on emerging social issues, such as downtown safety, homelessness, and harm reduction related to the opioid crisis, undertaking strategic corporate long range planning initiatives including parks planning, long-range property planning, public art and other corporate priority planning initiatives. The Senior Planner will play a key community liaison role for a range of community organizations and committees working on housing, homelessness, community health and safety, and downtown initiatives.

The incumbent exercises considerable independent judgment in planning and carrying out assignments, the ability to meet deadlines and set priorities, implement sound administrative and professional practices, deliver quality planning and policy initiatives, and achieve results on project implementation.

# Nature and Scope of Work

- Coordinates affordable housing research, funding applications, development of community partnerships and implementation of affordable housing initiatives;
- Collaborates with the Development Services Department to develop and implement innovative housing policies;
- Supports the development and administration of a policy for the City's social funding;
- Supports Safer Downtown initiatives including liaising with community organizations and assisting in coordinating and researching initiatives to support social programs;
- Coordinates strategic social planning initiatives;
- Undertakes long range parks planning including Master Plan development and supporting future parks planning initiatives;
- Supports the administration of public art initiatives and the development and implementation of the Art in Public Spaces Master Plan;
- Liaises with community organizations on housing, homelessness, community health and safety, downtown initiatives and other strategic priority areas;
- Assists with a wide range of long-range planning including comprehensive land use planning, neighbourhood planning, and policy reviews and the preparation of reports for consideration and approval by senior management or Council;
- Provides research, support and coordination of emerging corporate strategic long-range planning priorities;
- Drafts and recommends planning policies, procedures, and bylaws, and acts as an expert professional resource on affordable housing, social issues, parks planning, land use, development and zoning matters when assigned by Manager;

- Consults with the Manager of Long Range Planning and Sustainability on complex issues or matters of major impact;
- Prepares and delivers presentations to senior management, Council, City committees, community groups and the general public on planning issues, initiatives and projects;
- Responds to public inquiries; consults with and provides technical planning advice and recommendations to other departments, the general public and external organizations and agencies;
- Works collaboratively within the Long Range Planning and Sustainability Department, with the Development Services Department, and other City departments, local governments, agencies, consultants, contractors, developers and the general community to achieve long range planning and community development objectives;
- Attends and represents the Long Range Planning and Sustainability Department at Council, Public Hearings, advisory committees, community planning meetings and events as directed;
- Undertakes research projects and analysis, and prepares comprehensive planning reports for submission to senior management and Council;
- Conducts and facilitates public consultation meetings and workshops to address affordable housing, land use, and community development issues;
- Processes, analyzes and prepares reports regarding community development initiatives in terms of conformance with the Official Community Plan, bylaw requirements, local government objectives, and related provincial legislation;
- Provides technical direction to and coordinates the work of Long Range Planning and Sustainability staff as required;
- Performs other duties as required.
